



Schedule of Fees - 2018

Flag Membership: For Boat Owners

1. 50% Initiation Fee Reduction Promotion:

Temporarily reduce the initiation fee for prospective Flag members by 50% of the current "Schedule of Fees". This temporary reduction runs concurrently with the existing fee waiver of up to \$2,000 off the initiation fee for placing a boat immediately in a 24' slip. The prospective Flag member would have the choice of either fee reduction, but would not be eligible for both. The dues and quarterly minimum remain the same as all other current Flag and Regular members. This temporary reduction shall commence on May 19, 2017 and shall terminate unless otherwise authorized by the Membership at the May 18, 2018, Regular Meeting of the Members. This temporary reduction may be rescinded at any time by the Board of Directors.

2. Small Boat Promotion:

Initiation fee up to a maximum of \$2,000 will be waived if applicant, upon approval for membership, places their qualified boat immediately in a vacant 24' slip, as approved by the Port Captain. Waiver commences May 19, 2017, and shall expire May 18, 2018. This temporary promotion may be rescinded at any time by the Board of Directors.

1. Regular Member Initiation Fee Deferral:

Temporarily defer all but \$1,500 of the initiation fee for prospective Regular members of age categories with initiation fees set at \$1,500 or greater. The dues and quarterly minimum remain the same as all other current Flag and Regular members. In order to transfer to Flag status and be eligible for Slip Assignment, a Regular member (over) approved for membership after May 19, 2017 would be required to pay the remaining initiation fee based on their age and in accordance with the Initiation Fee in place at the time they request the status change. This temporary deferral was extended on May 19, 2017 and shall terminate unless otherwise authorized by the Membership at the May 18, 2018,

~ End & Side Ties are considered Double Slips. Rates are based on the slip size. Fees are based upon slip length or boat length, whichever is greater.

APPLICATION NOTES:

1. A non-refundable processing fee of one hundred dollars (\$100.00) will be submitted with the application. The processing fee will be credited against the Initiation Fee upon acceptance.
2. Upon recommendation of the Membership Committee, but before consideration by the Board of Directors, the new member must pay the current initiation fee. The new member's age at the time of application for conditional membership will determine the amount of the initiation fee. The new member has three (3) options to pay the current initiation fee:
 - A. Pay the entire initiation fee up front and in full
 - B. Pay a 30% down payment, along with a signed promissory note (24 monthly payments, 6% compounded annual interest)
 - C. Pay a 50% down payment, along with a signed promissory note (36 monthly payments, 6% compounded annual interest)
